

Microban technology is built-in to these products during the manufacturing process. When microbes come in contact with the product surface, Microban technology penetrates the cell wall of the microorganism and disrupts the cell, making the microorganism unable to grow and reproduce.









Clarion 25 with Microban Technology



Strip the floor with a Buckeye Floor Stripper (RipSaw® or Juggernaut®) with a black pad. Wet floor and allow floor stripper to stand 10–25 minutes depending on the number of coats needed to be removed. Machine scrub, pick up solution, and rinse floor with cold water.




After the floor is dry, apply a Buckeye Floor Finish. On day 1, apply 4 coats of Clarion 25 with Microban technology followed by 3 coats of Clarion 25 is the manufacturer's recommendation for best results.



Clarion 25 with Microban technology responds well to burnishing, but it is not required and is designed to fit any maintenance program.

Arena 300 with Microban Technology







Tack the floor with medium bristled push brooms, clean bath towels and Screen Clean as needed to remove remaining dust or residue. Mop edges and corners with clean mops and water.





Apply 2-3 coats of Arena 300 with Microban technology within recommended recoat window and allow floor to properly dry and cure with no traffic.

Deep clean and use an EPA Recognized Emerging Pathogen Disinfectant.

The Centers for Disease Control and Prevention (CDC) recommends cleaning and disinfecting frequently touched objects and surfaces following product label directions and proper dwell times. Buckeye's Eco® Proportioning Program is fully integrated with effective, hermetically sealed products, including EPA emerging pathogen disinfectants, for any application.

Spray high-touch areas with a Buckeye Disinfectant. Do not wipe down.

Empty Trash

Do not push down on trash as there may be sharp objects in the trash bag.

Spot Clean

Clean glass, acrylic glass and white dry-erase boards with a Buckeye Glass Cleaner. Spray soils with a Buckeye Muscle Cleaner. Let it dwell 2-3 minutes. For stubborn stains, agitate and wipe clean with a paper towel. Return to high-touch areas initially sprayed with a Buckeye Disinfectant (after 6-7-minute dwell time), spray areas again and wipe down (the last 2-3-minute dwell time will be achieved for complete disinfection).

High Dust

Clean in a clockwise pattern around the room everything above the shoulders.

Dust Mop or Sweep

Scrape up items stuck to the floor with a putty knife, being careful not to gouge the floor.

Damp Mop
